*Contributing to the IFRS® education of GenZ business students is the priority of PASSFR. PASSFR will construct a flexible but constructing structured digital learning platform.*

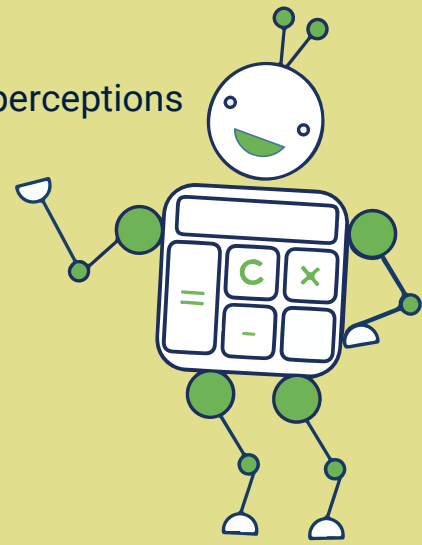

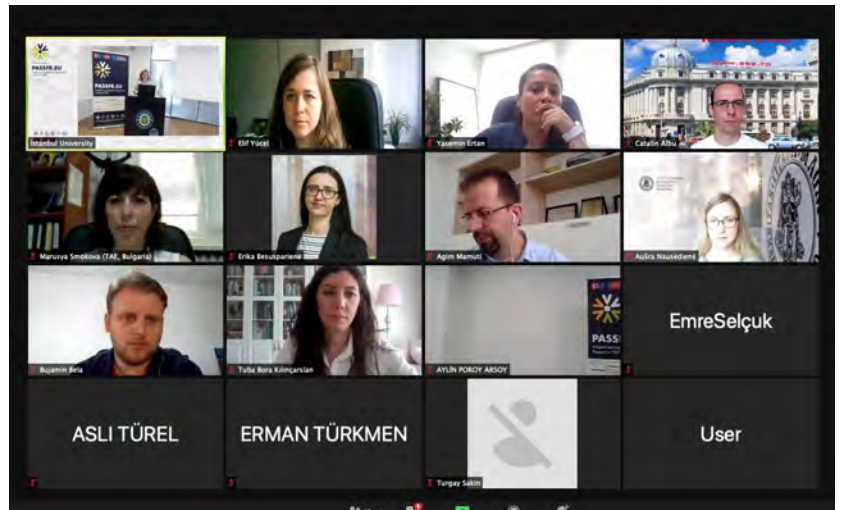
## Main Activities of the PASSFR
